SUBJECT: FINANCIAL STATEMENT FOR FISCAL YEAR 2007-2008

### **RECOMMENDATION:**

It is recommended that the Board of Directors review this memo, receive the presentation from the firm of Charles Z. Fedak and Company and approve the Financial Statement for Fiscal Year 2007-2008. A resolution is attached.

### **BACKGROUND:**

The District is required by State law to annually examine its financial records. The firm of Charles Z. Fedak and Company has conducted an independent audit of the District's financial records for Fiscal Year 2007-2008. This examination of the District's financial records was conducted in accordance with generally accepted accounting standards and principles. The Financial Statement for Fiscal Year 2007-2008 and Management Report will be transmitted under separate cover. A representative of Charles Z. Fedak and Company will be present to address your Board regarding this matter.

The Financial Statement furnishes information concerning the District's financial position and activities for the one (1) year period July 1, 2007 - June 30, 2008. Total operating income from all funds for FY 2007-2008 was \$3,459,598.00. This represents an increase in operating income from FY 2006-2007 in the sum of \$138,751.00. Total operating expenses for FY 2007-2008 was \$4,456,030.00. This represents an increase in operating expenses from FY 2006-2007 in the sum of \$496,386.00. The District's net assets at June 30, 2008 were \$25,394,201.00.

### **SUMMARY:**

The District has received the Financial Statement for Fiscal Year 2007-2008. This independent audit is required by State law and was conducted by the firm Charles Z. Fedak and Company. It is recommended that the District receive and approve the Financial Statement for Fiscal Year 2007-2008. A resolution is attached.
