BACKGROUND:

The Customer Service Department has completed its annual review of the accounts that have been given a variance from Multiple User Status, as provided in Ordinances 43 and 47. Those who qualify for the exemption are charged the \$40.04 bi monthly basic fee as a single-family dwelling, while those who are multiple users are charged a \$66.75 bi-monthly basic service fee.

Two accounts was removed from the variance list because the property changed ownership, the unit was found to be a permanent single-family dwelling, both units are occupied, or because the owner failed to send back the necessary compliance form. It is recommended that the accounts listed above and on the attached list be approved for a one-year variance from Multiple User Status. A resolution is attached.
