# **RECOMMENDATION**

Receive, review, and discuss a proposal by Acting District Manager Rick Rogers to enter into an employment contract to serve as the District Manager, and consider appointing designated representative(s) to negotiate such a contract with Mr. Rogers.

# **BACKGROUND**

At the regular meeting of the Board of Directors (Board) held on September 20, 2018, Acting District Manager Rick Rogers expressed interest in a three-year contract to serve as the District Manager, as an alternative to conducting external recruitment to fill the vacant District Manager position. The Board took no action to initiate external recruitment.

If the Board wants to explore the possibility of entering into an employment contract with Mr. Rogers to serve as District Manager, the next step is to appoint designated representative(s) to negotiate a proposed contract.

Following the appointment of designated representative(s) in open session, the Board should adjourn to closed session (without Mr. Rogers in attendance) in order to instruct the designated representative(s). The designated representative(s) will be responsible for negotiating with Mr. Rogers to bring a proposed contract back to the Board for review, discussion, and possible approval.
