We're gearing up for the 21st Annual River & Road Clean-up and I'm getting a late start. The summer flew by! I hope the District will be able to provide the dump truck and employees as in past years.

The Clean up will take place on Saturday, October 13th this year. The hours will be 9am to 3pm as usual, in the same three locations as in past years: Boulder Creek's recycling center behind the Village Wash & Dry, on Hwy 9 and Fillmore in Ben Lomond, and on Hihn St. by the parking lot of the Rite Aid in Felton.

The truck will not be needed before 11 a.m. and will be done by the 3:30 closing of the Transfer Station. The County will also provide truck and driver, and waive fees at the Transfer Station. As in the past we will keep the recyclables separate from the trash.

Would you please present this request to the Board? The event would not be possible without your assistance, and we are very grateful for the many years of support.

After this year's event, I have requested a meeting with Supervisor Mark Stone to evaluate the benefits and costs of the event. If I could impose upon you to provide me with the costs to the Water District, and any comments you or your employees have relating to the event to help in this evaluation, it would be very helpful. We should be meeting in early November and you will be welcome to attend the meeting if you desire. I'll keep you informed.
