SUBJECT: AB1234 Compliance Training

# **RECOMMENDATION:**

It is recommended that the Board of Directors review this memo and provide direction to staff regarding this matter.

# **BACKGROUND**

Assembly Bill No. 1234 (Assembly Member Salinas) requires all officials elected or appointed to a local government legislative body who receives any form of compensation or reimbursement to receive two (2) hours of ethics training every two (2) years. Officials in service as of January 1, 2006, must comply by January 1, 2007. New officials must comply within one (1) year of their election or appointment.

California Special Districts Association (CSDA) has announced a series of comprehensive ethics training at multiple locations throughout California. The closed location to the District is South San Francisco on Friday, February 24, 2006, 9:00 A.M – 11:00 A.M. See Attachment 1. This date and location would be a good opportunity for your Board to satisfy ethics training required by AB1234.

- New directors, trustees and designated representatives, must comply within a year of their election or appointment.
- Officials must receive training every two years.
