#### **<u>RECOMMENDATION</u>**:

## **BACKGROUND**:

The District is required by State law to annually examine its financial records. The firm of Charles Z. Fedak & Company has conducted an independent audit of the District's financial records for Fiscal Year 2005-2006. This examination of the District's financial records was conducted in accordance with generally accepted accounting standards and principles. A copy of the Annual Financial Report for June 30, 2006 (Fiscal Year 2005-2006) is transmitted under separate cover. A representative of Charles Z. Fedak & Company will be present to address your Board regarding this matter.

The Annual Financial Report furnishes information concerning the District's financial position and activities for the one (1) year period July 1, 2005-June 30, 2006. Total operating revenue from all funds for FY 2005-2006 was \$3,142,207.00. This represents a decrease in operating income from FY 2004-2005 in the sum of \$74,674.00. Total operating expenses for FY 2005-2006 was \$3,217,570.00. This represents an increase in operating expenses from FY 2004-2005 in the sum of \$480,047.00. The District's net assets at June 30, 2005 were \$25,466,105.00.

## SUMMARY:

The District has received the Annual Financial Report for June 30, 2006 (Fiscal Year 2005-2006). This independent audit is required by State law and was conducted by the firm Charles Z. Fedak & Company, Cypress, California. It is recommended that the District receive and approve the Annual Financial Report for June 30, 2006 (Fiscal Year 2005-2006). A resolution is attached.
