## RECOMMENDATION

It is recommended that the District Manager review this memo and request the Board of Directors adopt the attached resolution authorizing purchase of one (1) budgeted vehicle through Department of General Services, Procurement Division, California Multiple Award Schedule (CMAS).

## **BACKGROUND**:

The District's 2005-2006 Fiscal Year Budget provides for the replacement of one (1) vehicle. The vehicle scheduled for replacement is the Field Services Supervisor vehicle, Truck #311. This vehicle is a 1995 two wheel drive pickup with 114,000 miles on the odometer and has reached its life expectancy.

For procurement of the vehicle, staff will utilize the State of California Multiple Award Schedule (CMAS), otherwise known as the State Purchasing Agreement. Each year the State of California competitively bids a wide variety of equipment and supplies and then executes contract agreements with the successful low bidder to supply said items for a fixed period of time. The State's Purchasing Agreement (CMAS) is available to local government agencies. CMAS contracts are considered "price analyzed" because they are based upon formal competitive bid schedules for the State of California. Procurement through CMAS meets or exceeds District Ordinance 8, Article 18-Contracts and Purchasing Requirements. Staff will contact CMAS vehicle suppliers for pricing and availability. After purchase replacement, the existing vehicle will be declared as surplus and sold at auction.
