BACKGROUND:

YEAR END CLOSING

The auditors from the audit firm Charles Z. Fedak & Company have now completed their field work and will finalize the Annual Financial Statement.

WATER SAVING TIPS AND HOSE WASHERS

Insertion of "Water Saving Tips" in water bills is continuing along with written information regarding Phase Two of the District's Drought Contingency Management Plan. Staff is also continuing to pass out hose washers to interested customers at the front counter.

DEPOSITS AND INTEREST APPLIED

As of August 31, 2007 Deposits on account totaled \$101,245 and Interest on these deposits totaled \$10,934. We are over half way through the process of refunding deposits and interest to good accounts. Completion is expected by the end of the year.

RATE INCREASE EFFECTIVE JULY 1, 2007

All customers have now received their bills including the new 10% rate increase. The process has gone very smoothly.

AUTOMATED PAYMENTS

Customers are continuing to request that the District institute some type of automated payment capability. Staff is currently researching possibilities.
