RECOMMENDATION:

It is recommended that the Board of Directors review this memo and approve the attached resolution which authorizes the purchase of the subject properties.

BACKGROUND:

Your Board directed staff to negotiate a proposed Property Purchase Agreement for APN 081-241-08 and APN 081-361-01, 03, 04, 05, 06, 07 and 08, generally known as the Malosky Creek property. See Attachment 1. The property is presently owned by Roger Burch.

In January 2006 Sempervirens Fund secured a \$5,600,000.00 purchase option for two (2) separate redwood forest properties owned by Roger Burch. The two (2) properties subject to the purchase option are Lompico Headwaters Property (Islandia) which contains approximately 425 acres in Lompico and Malosky Creek Property which contains approximately 190 acres in southwest Boulder Creek. On May 15, 2006 Sempervirens Fund executed the purchase option with Roger Burch for these two (2) properties.

By correspondence dated May 15, 2006 Sempervirens Fund has authorized a fee title sale of the Malosky Creek Property to the San Lorenzo Valley Water District subject to one of the following terms. See Attachment 2.

- 1. \$1,750,000.00 cash offer, and a conservation easement restricting all timber rights associated with the property.
- 2. \$2,000,000.00 cash, with no conservation easement restriction.

It is recommended that your Board accept the terms of the \$1,750,000.00 cash and a conservation easement restricting all timber rights associated with the property.



Dear Jim:

This is to amend the Sempervirens Fund May 2 offer for the sale of the 188 acres Malosky Creek property.

In today's special meeting of the Sempervirens Board of Directors, the following terms were approved:

- 1. That Sempervirens Fund will accept the District's May 9 purchase offer of \$1,750,000 cash, subject to a conservation easement restricting all timber rights associated with this land.
- 2. That Sempervirens Fund will accept \$2,000,000 cash with no conservation easement restriction.

Both alternatives above accept the District's May 9 stipulation to fund the purchase escrow for this land on or before June 20, 2006.

We have previously provided a Phase One environmental impact assessment which found no outstanding environmental conditions on this land. Additional information is presented in the previously provided Santa Cruz County Title report.

Please call me if you have questions. We look forward to working with the San Lorenzo Valley Water District to complete this important land conservation transaction.
