BACKGROUND:

The Customer Service Department has completed its annual review of the accounts that have been given a variance from Multiple User Status, as provided in Ordinances 43 and 47. Those who qualify for the exemption are charged the \$32.50 bi monthly basic fee as a single-family dwelling, while those who are multiple users are charged a \$54.15 bi-monthly basic service fee.
