#### **RECOMMENDATION:**

It is recommended that the Board receive and consider the recommendations of the Education Program Advisory Commission regarding the current proposed Education Program Grants and provide direction to staff regarding the Board's award of said proposed grants.

### **BACKGROUND:**

On June 5, 2003 your Board approved District Ordinance No. 100 which created and established the San Lorenzo Valley Water District Education Program Advisory Commission. The purpose of the Education Program Advisory Commission is to advise the Board of Directors regarding the selection and allocation of education program grants.

At the November 15, 2005 Education Program Advisory Commission meeting, the Commission directed staff to notice the availability of grant funds. In addition, the Commission also directed Staff to specifically develop and notice a separate application process for Science Fair Projects. The Science Fair Project Education Grant Program encouraged grant applications with funding levels at or less than \$200.00 for Science Fair Projects which enhanced the understanding of the San Lorenzo River Watershed or improved the watershed's environmental health. Staff developed a simplified application process for the Science Fair Project Education Grant Program.

Staff noticed the availability of grant funding by direct mail to interested citizens, community groups and local schools, on the Districts website and through published display ads in local newspapers. The deadline for submittal of Education Grant Program Proposal Applications for this funding cycle was January 20, 2006. The deadline for Submittal of Science Fair Project Education Grant Program Proposal Applications was January 27, 2006.

In response to the Notice of Available for Education Grant Program Funding, the District received eleven (11) Grant Proposal Applications. See Attachment 1. The aggregate dollar amount of general grant applications received for the January 20, 2006 funding cycle was \$27,710.25. In response to the Notice of Availability for Science Fair Projects Funding,

the District received two (2) Science Fair Project Grant Proposal Applications. The aggregate dollar amount of the Science Fair Grant Applications for the January 27, 2006 funding cycle was \$400.00. See Attachment 2. For Fiscal Year 2005/2006 (July 1, 2005 – June 30, 2006), the District's budget provides for the availability of \$17,500.00 in total Education Grant Program Funds. To date, no Fiscal Year 2005/2006 Education Grant Program Funds have been allocated by your Board

At the February 25, 2006 Education Program Advisory Commission meeting, the Commission established guidelines for the evaluation and scoring of Grant Proposal Applications. In general, the guidelines established that each Commissioner would independently evaluate and score each Grant Proposal Application using an established scoring matrix. Upon completion of the independent reviews by each Commissioner, the scored Grant Proposal Applications were returned to District staff. The scores for each proposal were compiled by District staff and each Grant Proposal Application was assigned an overall proposal rating. Due to the resignation of one (1) Education Program Commissioner the overall proposal ratings for this funding cycle was based on a review by the remaining four (4) Commissioners. See Attachment 3.

At the April 5, 2006 Education Program Advisory Commission meeting, the Commission reviewed and discussed the aggregate scores and ranking order of the Education Grant and Science Fair Applications received relative to the current funding cycle. At said Commission meeting, the Commission recommended the funding and allocation of San Lorenzo Valley Water District Education Program Grants to nine (9) applications in the aggregate amount of \$17,500.50. The recommended applications and funding amounts are as follows:
