DIRECTORS SAN LORENZO VALLEY WATER DISTRICT

### **RECOMMENDATION:**

It is recommended that the Board of Directors review this memo and by Motion of the Board, direct staff to notice a vacancy in an elective office of the Board of Director's in accordance with applicable provisions of the California Government Codes.

### **BACKGROUND:**

By correspondence dated April 4, 2006 David Ross has submitted notice of his resignation from the San Lorenzo Valley Water District Board of Directors as of April 20, 2006. See Attachment 1. Director Ross was first elected to the San Lorenzo Valley Water District Board of Directors in November 1988 and has served continuously since said date.

Pursuant to California Government Code Section 1780, in the event of a vacancy in an elective office on a governing board of a special district the remaining board members may fill the vacancy by appointment within sixty (60) days of the effective date of the vacancy. Therefore, appointment to fill the vacancy must occur prior to June 19, 2006. Notice of the vacancy must be posted in three or more conspicuous places in the District at least fifteen (15) days prior to the appointment. Further, the San Lorenzo Valley District Board of Director's Policy established a closing date for the receipt of applications for the vacancy.

It is recommended that the Board of Directors fill the vacancy in the elective officer of the Board of Directors by appointment and establish Friday, May 19, 2006, 5:00 p.m. as

the closing date for the receipt of applications. See Attachment 2. Pursuant to the Board of Directors Policy Manual applicants would be scheduled for interview at the June 1, 2006 Board of Directors Meeting. Appointment may be made at the June 1, 2006 Board of Director's Meeting.


Dear People:
