- a. California Performance Review (Oral)

Manager Mueller stated that Governor Schwarzenegger is proposing a new framework for California State Government. The released report is 2,500 pages and states that the proposed changes in framework would result in approximately \$32 billion dollars in savings. Manager Mueller does not have a thorough analysis of the entire document but some familiarity with

the overall concept. Manger Mueller stated that the recommendations in the report face steep challenges. Manager Mueller indicated that nothing indicates a change in local government. District staff will continue to monitor the potential impacts and changes.

Dir. Nelson thanked the manager for presenting the material.

Dir. Rapoza stated that he read a summary on the internet regarding realignment of certain funding mechanisms between the state and county. Dir. Rapoza requested that staff have CSDA due an analysis on funding and fiscal impacts relative to local government. Manager Mueller indicated that CSDA is already working on these issues.
