Roberta McPherson, Boulder Creek, also wants to express her gratitude to the outgoing board member for their long service. She recognized that the job is not always easy. She also thanks the new board members for putting themselves in the position.

John Fasolas, Felton, said that he told the Board how much he appreciates them, he would like to talk about our water tables. He would like to encourage the Board to work to bring up the water tables.

Jim Coffis, Ben Lomond, wanted to express his appreciation to the outgoing board for their many years of service and for not only maintaining but enhancing the quality of life in the valley by the actions that they have had the wisdom to take. He believes that the vast majority of the public share his appreciation.

Bruce Holloway, Boulder Creek, said that in April the Board created a Water Shortage Appeals Board and put 3 members on that Board. He thinks it's a bad idea to put a majority of the Board but not the whole Board on something like that.

Julie Hendricks, Boulder Creek, she is also Mrs. Prather. She attempted to set the record straight regarding some inaccuracies written about her husband the District.

Fred McPherson, Boulder Creek, thanked his fellow colleagues. He knows that the job is not easy and not always appreciated. Don't complain if you're not willing to serve. Thank you.

Eric Hammer, Boulder Creek, thanked the individuals that helped us get here for all of their time and energy.

WRITTEN COMMUNICATION:

Raymond Zachau, Felton, disagreed with legal counsel. The Brown Act violation is the agenda item in the Acting District Manager's status report that says the District is in the process of transferring the property.

Marc Hynes said that there is an item on tonight's agenda that will clear up all questions. No actions have actually been taken at this time.

BOARD OF DIRECTORS POLICY MANUAL 2015

Pres. Bruce questioned whether the Board can move all of the items listed for the 1^{st} meeting in December to the 2^{nd} meeting in December or the 1^{st} meeting in January.

Marc Hynes said that the Board can do whatever they want with the exception of the election of officers which must take place the 2^{nd} meeting in December. Marc also brought to attention the item on page 10 regarding overbroad language with reference to disruptive comments. He borrowed this language from a court approved source.

Dir. Rapoza noted that the Policy Manual states that the Board will set the calendar for the year of meetings on the 1st meeting in December, this should be changed to the 2nd meeting in December when the New Board is seated. Pres. Bruce agreed.

AWARD OF BID - SURPLUS PROPERTY SALE

Acting District Manager Rogers read the memo regarding the Award of Bid.

Dir. Vierra questioned the bid process. Pres. Bruce requested the dates of the process.

Bruce Holloway, Boulder Creek, suggested that, in the future, the District hold an auction instead of a sealed bid. Bruce questioned if the District should retain easement to this property.

Dir. Vierra explained that the property was analyzed and determined to be of no significance to the District.

Acting District Manager Rogers agreed that the property was personally visited to determine its value.

Raymond Zachau, Felton, said that the property used to be part of a resort in the 1920's and was a swimming area. Also, he said he asked for a copy of the District's bid policy and Rick was not able to provide it.

Mike Shults, Ben Lomond, questioned why he didn't buy this property long ago.

Lisa Rinelle, Ben Lomond, said that they had tried to buy the property years ago.

Dir. Rapoza said that the District is not part of this dispute.

Dir. Rapoza made a motion to accept the \$10,010 bid from Mike Shults for APN 065-202-15
