Bruce Holloway, Boulder Creek, addressed the Board regarding the Board Policy Manual. He would like to see the Board comply with state law.

 - (1) Bill List Period Ending October 16, 2014.

Director Brown would like to see more detail on the PG&E bills. A quarterly spreadsheet with the information for all accounts was suggested.

Karen Brown, Boulder Creek, questioned the missing check numbers, again.

Finance Manager Hill, explained that this is not a check register log.

Motion made by Dir. Rapoza to approve the Bill list for the period ending October 16, 2014 in the amount of \$466,731.

Noes: None Abstain: None Absent: None (2) Investment Report for the most recent available statements. Finance Manager Hill notes that \$150,000 was transferred to Wells Fargo from Morgan Stanley. She points out that LAIF has a slightly better interest rate (Wells Fargo .2%, LAIF .22%) but transfer fees make the amounts even.

Bruce Holloway, Boulder Creek, pointed out page 7 on the Morgan Stanley report. The dates for the purchases of CDs were after the policy change in 2011.

Director Vierra said that this is in the past. The District Manager at the time made unauthorized purchases.

Director Rapoza as part of the finance report going forward, suggested that we pick a day, for example the end of the month, and list how much is in each account.

(3) District Status Reports

Receipt and consideration by the Board of Department Status Reports regarding ongoing projects and other activities.

Acting District Manager Rogers noted that we are still out to bid for Interties 2, 3, & 4. Olympia Mutual has approx. 2000 feet complete. Expect a report to the Board in November from Nick Johnson, Hydrologist.

(4) Leak Adjustment Status Report
Finance Manager Hill noted that the leaks are being caught quickly thanks
to monthly billing.

Charles Baughman, Boulder Creek, thinks it may be interesting to find out the amount of water involved in this report.

(5) Water Conservation Programs Credit Status Reports
Finance Manager Hill noted that this program has been very successful.

 Scotts Valley Town Plan was discussed as well as leak detection and meter replacement.
