REDWOOD TANKS REPAIRS

Director of Operations Rogers presented to the Board the state of the three (3) most problematic Redwood Tanks and the conclusions and recommendations of the Facilities & Planning Committee.

Director Vierra noted that it is not feasible to line the Probation tank vs. replacement due to the fragility of the redwood.

Peter Lang, Boulder Creek, addressed the Board to question the reconfiguration of the tanks locations and capacity. Also, can the tanks be less full to save the quantity of leaking.

Director of Operations Rogers noted that elevation is a requirement and redwood tanks must be full to keep them wet/viable.

Director Brown questioned the 24 months required for the incidental tank permit.

District Manager Mueller explained the process for the environmental site permit and review.

Dir. Rapoza noted that he would be disappointed if the only action was to be the replacement of the Probation Tank only.

Nick Nicarri, Ben Lomond, has video of leaking of Probation tank. He questioned bids for the project.

Pres. Bruce asks if we defer action on the Probation tank are we risking catastrophic failure.

Director of Operations Rogers says that during the Loma Prieta earthquake the leakage increased but there was not a catastrophic failure.

Mark Lee, Ben Lomond, addressed the Board with his research into replacement tanks. He shares information for bolted corrugated steel tanks with lower prices.

Pres. Bruce states that the committee recommended that the RFP for the Probation tank replacement be in the 2014-2015 budget.

Dir. Prather notes that the price of replacement tanks includes geotechnical survey and an engineered foundation.

Mark Lee, Ben Lomond, inquires as to experimenting with sealants. He offered to assist.

Motion made by Dir. Prather direct staff to follow the recommendations of the Facilities & Planning Committee.
