 - a. CZU WILDFIRE DAMAGE ASSESSMENT REPORT
 R. Rogers introduced this item.
 - J. Furtado described the status of the damage and progress on Lyon Treatment Plant and tanks, boosters, etc. The projects are winding down.
- R. Rogers added that they are discussing the types of material and construction methods on the permanent replacement piping.

 CONJUCTIVE USE PLAN CEQA & ENVIRONMENTAL PERMITTING CONSULTANT SELECTION
 R. Rogers introduced this item. C. Blanchard read from the memo and recommended that the Board authorize the District Manager to enter into an agreement with Rincon Consultants.

Discussion by the Board and staff regarding water rights, extreme requirements, cost of the consultant, fisheries, and grant possibilities.

- B. Thomas questioned the Felton water rights.
- R. Moran made a motion to authorize the District Manager to enter into a professional service agreement with Rincon Consultants, Inc. for the Conjunctive Use Plan for CEQA and environmental permitting. The motion was seconded.
