a. Full Reconveyance of Deed of Trust; Semperviren's Fund, Inc.

Manager Mueller reported that on October 18, 2000 the District closed escrow on a Purchase Agreement which sold the District's Waterman Gap property to Semperviren's Fund, Inc. for the purchase price of \$10,900,000.00. On May 21, 2004 the District received a final installment payment from Semperviren's Fund, Inc. which fully satisfied all outstanding indebtness relative to the Purchase Agreement. Manager Mueller is recommending the Board approve Full Reconveyance of the Deed of Trust. In addition, Manager Mueller made two (2) corrections to agenda item 8-a.

Dir. Rapoza stated that the purchase of additional watershed property from the proceeds of Waterman Gap funds has been offset by the investment interest.
