## NEW BUSINESS:

a. Budget Amendment and Award of Bid; Underground Fuel Storage Tank Removal Project

Manager Mueller reported that the District currently owns and operates underground fuel storage tanks at two (2) locations: District Administration Building (diesel and gasoline) and Bear Creek Estates Water Works Facility (diesel). Effective January 1, 2004 USEPA adopted new regulations regarding underground dispenser containment. The District's existing underground fuel storage tanks do not comply with the new regulations. Manager Mueller reported that District staff explored the required improvements and costs associated with compliance. Based upon the estimated costs for improvements and, additional regulatory costs associated with continued operation of underground fuel storage tanks, District staff is recommending that the tanks be removed from service. Manger Mueller reported that all three (3) tanks have been out of operation since fall 2004.
