a. Annual Steelhead Report; March 2005

Manager Mueller stated that the subject report provides a comparison of juvenile steelhead densities for the year 1997-2001 and 2003-2004 within the middle and upper San Lorenzo River and four (4) tributaries. In addition, the report provides an estimate of juvenile populations.

Don Alley with D.W. Alley & Associates was present to present the Annual Steelhead report dated March 2005 to the Board of Directors. Mr. Alley stated that when Kinko's duplicated the report, pages numbers were left out. Mr. Alley stated that he will make sure the correction is made and provide the District with a correct copy before any reports go out to the public.

Mr. Alley stated that densities and production of Young of the Yearlings in the middle and upper mainstem decreased from 2003 to 2004. In the middle river, yearling densities and production increased slightly from 2003-2004, as it had the previous year, but Size Class 2 and 3 (smolt-sized juvenile) densities and production did not. From 2003 to 2004 there was a 45% decrease in smolt production in the middle mainstem river, but 16% increase in the upper mainstem river, resulting in a 5% decline in the overall mainstem. In all four (4) monitored tributaries (Zayante, Bean,

Boulder and lower Bean), densities and production of Young of the Yearlings (Size Class 1 fish) and yearlings (Size Classes 2 and 3 smolt-sized fish) decreased in 2004. From 2003-2004, the index of adults returning from the juvenile population increased slightly for the upper mainstem segment and decreased for the middle mainstem and each tributary.
