

## Weather-Based Irrigation Controller Credit Application

San Lorenzo Valley Water District (SLVWD) offers credits to customers for Weather-Based Irrigation Controllers. Please see our website at <u>www.slvwd.com</u> for more information or call (831) 338-2153 for assistance.

Weather-based irrigation controllers have clocks that use current weather information to automatically apply the appropriate amount of water to the landscape. They can be installed new or replace an existing controller.

## Please read the Credit Program Requirements on the backside of the Application for Approval. All credit applications require the signature of the property owner (if different than the applicant).

## Weather-based Irrigation Controller - Credit Application for Approval: Rules & Requirements

1. Credit application must be submitted for approval prior to installation. Installation must be complete within 60 days of item purchase. An original, dated sales receipt showing itemized cost for the credited item must be provided. If you need the original receipt returned, please enclose a self-addressed, stamped envelope with your credit application. For online purchases, a print out of the final invoice and an original packing or delivery slip is required.

2. All credit applications for approval must be signed by the legal property owner.

- 3. To qualify for a weather-based irrigation controller credit, you must purchase and install one of the following:
  - a. Sensor-based controllers use on-site weather or solar sensors to create irrigation schedules (up to a \$75 credit).b. Signal-based controllers rely on daily weather updates received from satellite signals or require an internet connection to receive the information (up to a \$125 credit).
- 5. No credit will exceed the purchase price of the item. Sales tax and labor are not credited.

6. The credited equipment must be installed at an existing San Lorenzo Valley Water District (SLVWD) service address. New development is not eligible for credits.

7. A representative of SLVWD must be permitted to inspect the property to verify proper installation.

8. Credits are applied as a credit that will appear on a subsequent water bill. The account must be in good standing to receive a credit. Upon closing an account, any credit balance will be mailed to the account holder. Allow four weeks from the date of approval for credit processing.

9. You will be issued a check in lieu of a credit if: (1) your SLVWD water service is in the name of your Home Owner's Association or Condominium Board and you are the legal property owner of your dwelling unit.

10. Installation of any credited device, appliance or fixture is the sole responsibility of the applicant, as is determination of the adequacy and compatibility of the existing plumbing system.

11. SLVWD does not endorse specific brands, products or dealers; nor does it guarantee materials or workmanship; acceptance of such is customer's responsibility.

12. SLVWD assumes no responsibility or liability for any damage that may occur to an applicant's property as a result of participation in the program. Due to circumstances beyond its control, SLVWD cannot guarantee that installation of credited fixtures or measures will result in lower utility costs.

13. The applicant is solely responsible for the proper disposal of all materials associated with the installation of credited fixtures and equipment and SLVWD assumes no responsibility or liability. Please recycle materials.

14. SLVWD may at any time, modify, suspend, or terminate this program without prior written notice.

15. Incomplete or illegible application will be denied.
