**ADDENDUM NO. 1**

**1. GENERAL**

*Scope*

This addendum modifies the Contract Documents dated March 17, 2020, for the San Lorenzo Valley Water District 2020 Pipelines Replacement Project, and the work shall be accomplished in accordance with such modifications. This Addendum includes two (2) pages plus one (1) attachment (total of 3 pages).

The Addenda includes Contractor Information Items, responses to questions, changes to the Bid and Contract Documents, followed by attachments.

Note: The Bid Date is April 22, 2020.

*Acknowledgment*

Bidders must acknowledge this addendum as part of the bid submission by completing bidder's acknowledgment of addenda (Section 00300). Failure to acknowledge the addendum may constitute grounds for rejection of the bid.

**2. CONTRACTOR INFORMATION ITEMS**

- A. The pre-bid meeting is cancelled due to the current County shelter in place order. Contractors may visit the work locations to assess the existing pavement conditions, so long as they comply with the County social distancing guidelines.
- B. Santa Cruz County Public Works has stated that Type II slurry sealing will not be required for these sites.

**3. RESPONSES TO QUESTIONS**

- A. Is the pipeline in California Drive and Middle Drive to be fully restrained?
  - a. Yes. See Note 1 on Sheet C1.1.
- B. Are thrust blocks required on any sites?
  - a. Yes. Concrete thrust blocks are required where tees and valves are cut into the existing pipeline in Fern Avenue, and at the new PRV station. All other pipelines are to be mechanically restrained.
- C. Which permits is the Contractor responsible for obtaining?
  - a. Contractor shall obtain Santa Cruz County Encroachment Permits. The permit fee is paid under Bid Item 19, Permit Fees.

**4. CHANGES TO VOLUME 1, CONTRACT DOCUMENTS AND TECHNICAL SPECIFICATIONS**

The following sections are amended as noted:

- A. Section 00020, Invitation to Bidders, is amended as follows:
