ADDENDUM NO. 2

1. GENERAL

Scope

This addendum modifies the Contract Documents dated March 17, 2020, for the San Lorenzo Valley Water District <u>2020 Pipelines Replacement Project</u>, and the work shall be accomplished in accordance with such modifications. This Addendum includes two (2) pages plus two (2) attachments (total of 4 pages).

The Addenda includes Contractor Information Items, responses to questions, changes to the Bid and Contract Documents, followed by attachments.

Note: The Bid Date is changed to April 23, 2020.

Acknowledgment

Bidders must acknowledge this addendum as part of the bid submission by completing bidder's acknowledgment of addenda (Section 00300). Failure to acknowledge the addendum may constitute grounds for rejection of the bid.

2. CONTRACTOR INFORMATION ITEMS

- A. The District office is closed to the public due to the current Santa Cruz County shelter in place order. Contractors must submit their bids by mail or other delivery service. The bid date is extended to April 23 to allow for the delivery time. Bids will be opened on April 24 and results will be made available on the District website.

3. **RESPONSES TO QUESTIONS**

- A. Questions were received asking to confirm the quantities of several bid items.
 - a. Corrected quantities are provided on the revised Bid Schedule, included with this addendum. For Bid Item 7A, the bid quantity remains 2, for the two services shown on sheet C1.6.
- B. The Bid Schedule calls out 1" Air/Vac valves, but detail SD-7B shows a 2" ARV. Which size is required?
 - a. 1" ARVs are required. Sheet C6.1 is corrected as noted below.

4. CHANGES TO VOLUME 1, CONTRACT DOCUMENTS AND TECHNICAL SPECIFICATIONS

The following sections are amended as noted:

A. Section 00020, Invitation to Bidders, is amended as follows:

Page 1, Receipt and Opening of Bids

- A. Sealed Bids will be received by Holly Morrison at SLVWD, 13060 CA-9, Boulder Creek, California, 95006, Telephone (831) 338-2153 until 3:00 p.m. on April 22 5:00 p.m. on April 23, 2020 for the construction of the Work entitled: 2020 Pipeline Replacements.
- B. Bids will be publicly opened and read aloud at the place and time stated above. Bidders are invited to be present at 8:30 a.m. on April 24, 2020 at the place stated above. A summary of bid results will be posted on the District website by 12:00 p.m. on April 24, 2020.
- B. Section 00100, Instructions to Bidders, is amended to add the following immediately after paragraph IB-04.F:

<u>G.</u> All Bids must be submitted by mail or other delivery service. The District office is temporarily closed to the public due to the Santa Cruz County shelter in place order.

C. Section 00300, Bid Proposal, is amended as follows:

Page 6, Bid Schedule, is replaced with the attached version (Attachment 2). Quantities are corrected for bid items 4, 6, 10 and 12.

A. Sheet C6.1, Standard Details, the following detail is amended:


