TO ALL PROSPECTIVE BIDDERS:

Addendum No. 1 provides for deletions, corrections, clarifications, and additions to the Request for Qualifications (RFQ) for Construction Bids for the Fire/Vegetation Management Annual Maintenance; these deletions, corrections, clarifications, and additions shall apply in the same manner as if they were originally part of the RFQ.

**1. Section II, General Information** did not specify wage requirements.

- a. **This section is revised as follows:** “LOCAL WAGE RATES. In accordance with the laws of the state Department of Industrial Relations and jurisdiction where the Work is located, SLVWD has determined and adopted the general prevailing per diem wages, including wages for overtime and holiday work, for each craft or type of workman needed in the execution of the Work. Said wages shall be the minimum paid to workmen employed for the Work. Copies of the wage determination are on file and may be obtained by interested parties at San Lorenzo Valley Water District, 13060 CA-9, Boulder Creek, California 95006”

**2. Section II, General Information** revised to offer a tour of sites.

- a. This section is revised as follows: “A pre-bid site tour is scheduled from 9:00 a.m. through 4:00 p.m. on February 8, 2023. Prospective Bidders will be given a map of example sites and allowed to access each on their own within the allotted time frame. Following the tour questions can be sent to Environmental Programs Manager at CBLANCHARD@SLVWD.com and Q&A will be posted to the District website as an addendum to this RFQ within 48 hours. Bidders unable to attend the pre-bid site tour as specified in this section may make arrangements prior to 5pm on February 6, 2023 to tour the site on another date. Such arrangements may be made by emailing the District Environmental Programs Manager at CBLANCHARD@SLVWD.com”

**3. Revision to RFQ:**

- a. **Section XVIII. SUBMITTAL REQUIREMENTS**, 2., states “The SOQ must be received no later than 3:00 p.m. local time, on or before February 03, 2023 to Carly Blanchard at: cblanchard@slvwd.com Failure to comply with the requirements of this RFQ may result in disqualification. Questions regarding this RFQ shall be submitted in writing to cblanchard@slvwd.com by January 30th, 2023. The District will not respond to questions submitted after January 30th, 2023.”
- b. **Section XVIII. SUBMITTAL REQUIREMENTS**, 2., is revised to state: “The SOQ must be received no later than 3:00 p.m. local time, on or before February 17, 2023 to Carly Blanchard at: cblanchard@slvwd.com Failure to comply with the requirements of this RFQ may result in disqualification. Questions regarding this RFQ shall be submitted in writing to cblanchard@slvwd.com by February 10th, 2023. The District will not respond to questions submitted after February 10th, 2023.”

c. The District has elected to extend the bidding period as described above
