

SAN LORENZO VALLEY WATER DISTRICT MAIN FLUSHING PROGRAM 2020

The San Lorenzo Valley Water District is preparing to undertake our annual water main flushing program in your neighborhood. The purpose of this program is to remove iron and manganese deposits which accumulate in the distribution system piping of the Zayante and Hihn Road areas.

From time to time, some District customers may have experienced periods of discolored water caused by iron and manganese. Iron and manganese are common minerals found in groundwater wells throughout the nation. Although these minerals do not pose a health threat to consumers, iron and manganese can affect the aesthetic quality of water. Iron and manganese can precipitate and deposit in the water mains. Occasionally, during higher flows the deposits become dislodged resulting in discolored water. This discolored water can sometimes cause staining of clothes and plumbing fixtures.

To remove these deposits, the District will be flushing the main distribution system piping in your neighborhood. The scheduled dates for flushing are:

FEBRUARY 1 - 5, 2021 (Monday - Friday)-North System

East Zayante Rd. from Zayante Fire Station to East Creek Road, including the side streets of Creekside Way, Madrone Way, Rosebloom Ave., Sylvan Way, Valleyview Way, Waner Way, Westwood Rd. and Zayante School Rd.

FEBRUARY 8 - 12, 2021 (Monday - Friday)-North System

Azalea Dr., Elm Dr., Lilac Dr., Newton Dr., Olympia Circle, Pine Dr., West Zayante Rd. and Willow Dr.

FEBRUARY 16 - 19, 2021 (Tuesday - Friday & Monday)-North System

FEBRUARY 22, 2021 (Monday)

Hihn Road, Moon Meadow Lane and Storm Rd., including the side streets of Archer Way, Azalea Ave., Bahr Dr., Condor Ave., Crown Dr., East Canyon View, East Terrace Dr., Eleana Dr., Harvard Dr., Indian Springs, Kim Way, Larita Ave., McAdams Lane, Melin Ave., Morningside Dr., Noteware Ct., Ridgeview Dr. and Stanford Dr.

Flushing will occur between the regular business hours of 9:00 a.m. and 4:00 p.m. The District requests your cooperation by asking that you reduce water usage during this period. Please refrain from doing laundry, as the water may be discolored for a short time. In addition, you may experience periods of low water pressure and/or interruption of water service. Please mark these dates on your calendar, as this will be the only direct notice you will receive.

Every effort will be made by District Staff to perform this operation with minimal disruption of service and inconvenience to our customers.

Consistent periodic flushing will help to improve water quality and minimize those surprising episodes of brown water that have occurred in the past. Thank you for your cooperation.
