Per spec section 01312 Construction Schedules Part 1, 1.02 C.3 the contractor shall include any assumed overtime and specifically identify such overtime hours and days.

Syblon Reid will require working up to 10 hours per day (7:00 am – 5:00 pm), Monday – Friday to meet the proposed schedule herein. Although not shown on the baseline schedule, we also anticipate the possibility that we will need to work some Saturday's to make up for construction days lost due to weather delays or other potential project delays.

Comments:

1. Per executed contract Section 00500 Contract Agreement, Covenant 1: The contract time is hereby established as 270 calendar days from the date of receipt of the Notice to Proceed.

The revised schedule appears to show activities through February 15th, 2024. The Notice to Proceed was signed and returned on April 25th, 2023. Please revise the Baseline Construction Schedule to show all tasks completed within 270 calendar days starting April 25th, 2023.

The Baseline Construction Schedule has been revised to show the correct date of execution of the Notice to Proceed and to show all tasks completed within 270 calendar days.

2. The revised construction schedule appears to show the removal of the cofferdam and bypass on October 13th, 2023 but the temporary Intake operating until December 14th, 2023. MME takes no exception to this proposed means and methods provided the temporary intake can operate without the cofferdam for two months

The Baseline Construction Schedule has been revised to show that SRC will setup temporary power and controls for the permanent intake system before the temporary intake system is removed. The permanent intake will operate on temporary power until the permanent power and controls are procured and installed.
