BACKGROUND

In September 2022 the Board of Directors recommended the District Manager enter a contract with Miller Maxfield Inc (MM), to complete outreach. Since their contract award MM has worked with District staff to establish regular social media posts, press releases, and monthly newsletters. MM will be presenting their work thus far and include information on quarterly status reports that will be provided to the Board at future meetings.

PRIOR COMMITTEE ACTION
