Subject: Possible Lompico Assessment District Oversite Committee

Disbandment Date: August 26, 2022

At the July 12, 2022, Lompico Assessment District Oversite Committee (LADOC) meeting, the Committee voted unanimously in favor of disbanding the Committee after completing the 2021/2022 Annual Report.

In light of the Committees' interest in disbanding, District Staff is presenting the following steps for the Committee to consider as a possible process for disbanding LADOC. These steps would allow the District and LADOC time to perform public outreach, inform the community of Lompico of the possible action, and allow time for the community to comment.

- 1. August 2022 Informational item (no action) informing LADOC about what the process would entail if LADOC continues to want to disband.
- November 2022 Assuming LADOC continues to express interest in disbanding, advertise (mass mailing within Lompico) that the issue will be considered by LADOC at an upcoming meeting; LADOC meeting agenda would include an item reflecting possible action by LADOC to vote to recommend that the Board disband LADOC by repealing the LADOC charter and amending the Board Policy Manual.
- December/January 2023 An informational item may be presented to the Board in December, prior to presenting it as an action item to repeal the LADOC charter and amend the Board Policy Manual in December or January.

Creating the LADOC Committee and LADOC charter were essential steps in the consolidation process of the Lompico County Water District into the San Lorenzo Valley Water District.

Public outreach should be considered to notify the folks in Lompico in the form of a mass mailing, giving time for interested members of the community to voice their opinion one way or another on any possible disbanding the Committee. Transparency is of the utmost importance with this issue.

RECOMMENDATION:

It is recommended that the Committee review the LADOC attached memo and vote to approve the Board's assignment of Director Fultz as LADOC Liaison.

BACKGROUND:

The LADOC Charter Section 8 District Support states:

The District shall appoint one board member to serve as liaison to the Committee, to be approved by both the Board and Committee, and reviewed after a one-year term, or earlier if requested by the Committee. The board member shall have no power to vote on or direct Committee actions but is there to assure the uninterrupted and full support of the General Manager or designated staff to the Committee to enable carrying out their duties. A preference is for this appointee to be the Board President.

On July 21, 2022, at the Board of Directors meeting of the San Lorenzo Valley Water District, the President of the Board appointed Director Fultz as the Board Liaison to the LADOC. Director Fultz will serve a one-year term as liaison.
