NOTICE IS HEREBY GIVEN THAT THE SAN LORENZO VALLEY WATER DISTRICT is seeking applications for interested members of the community to participate as a Member of the PUBLIC ADVISORY COMMITTEE ON FACILITIES

The Public Advisory Committee on Facilities (PACOF) is responsible for the review of District administrative and operational facilities needs and shall consist of 5 to 7 members of the public. The term of the PACOF members is one year beginning on the date that the first committee member is appointed by the Board. The anticipated time commitment for this committee is one meeting per month, 1 or 2 Saturday workshops, and field trips to existing District facilities.

The Committee is responsible for making recommendations in the form of one or more written reports to the Board on the following: history of procurements and current status; opportunities and constraints; appraisal value; current and long-term needs; location(s); design; consolidation; emergency needs; fuel storage and environmental concerns; bulk water sales; construction cost estimates; any and all other concerns regarding the District facilities.

The Committee meeting will be open to the public and be subject to the Ralph M. Brown Act (https://www.cacities.org/Resources-Documents/Resources-Section/Open-Government/Open-Public-016.aspx) and all other applicable federal, state or local laws, rules and regulations.

Applicants for the PACOF must be residents of the San Lorenzo Valley Water District sphere of influence.

Any person interested in filling a position on the PACOF must complete an application. Applications will be reviewed by the Board. The appointments will be announced at the February 6, 2020 Board of Directors meeting.
